

# SCOIL CHOLMCILLE SMARTPHONE & SOCIAL MEDIA VOLUNTARY CODE

## What does this voluntary code mean?

The **Smartphone & Social Media Voluntary Code** is a no smartphone & no social media policy whereby parents collectively agree to not provide their children with access to smartphones or social media while in primary school.

In a recent **survey** shared with all parents/guardians (Dec 2023) on this topic and in preparation for this change **97% of respondents were in favour** of this new code with 55% opting to wait until children finish primary school (vs. confirmation time in 6th class).

Similarly students in 3rd - 6th class were also surveyed with **80% of students** saying that age 12+ is an appropriate age for a child to have their own smartphone. The majority of students also strongly agreed that having a smartphone could impact a child's performance in school such as being distracted, concentration level, poor quality of work etc.

The internet and social media is becoming a bigger part of our children's lives, mostly for the better however it poses risks and dangers too. Our children are very often not emotionally ready to navigate the **complexities of digital devices and the digital world**. Research also shows that devices and social media are having a detrimental impact on children's **ability to learn, focus and retain information**.

This voluntary code is born out of a need for we as parents/guardians and teachers to do everything we can to **protect our children** or as long as possible and **set them up for success** as they head into their teenage years.

**Collective agreement** on delaying the introduction of smartphones & social media access during the primary school years should also we expect **reduce peer pressure** amongst our children and thereby act as a **tool to support parents/guardians** when having conversations with their children about access to smartphones & social media.

### **Key Points:**

1. This is a voluntary code - Scoil Cholmcille Parents Association, Principal and school staff respect each family's right to decide whether or not their children have access to a smartphone or social media.
2. All data collected (e.g. families who do/do not participate) remains anonymous and will only be shared on an aggregated by class basis.
3. The voluntary code does not affect basic mobile phones or similar devices (e.g. SmartWatch with no internet access or apps) which children may require to maintain contact with a parent or guardian after school hours.

4. The voluntary code does not affect the existing in-school policy whereby the use of mobile phones and smartphones are not permitted on school grounds. This new agreement is to extend this policy to now also include within the home and all social settings.
